The Chairman welcomed the participants and after introductory remarks, the Committee thoroughly examined list of un-employed candidates furnished by District Employment Exchange Peshawar and decisions taken as under:-


SELECTION AGAINST TWO VACANT POSTS OF NAIB QASID (BPS-01) AND ONE POST OF RESIDENCE ORDERLY (BPS-01)


Out of a list of four hundred and twenty five (443) candidates for the two posts of Naib Qasid (BPS-01) and one post of Residence Orderly provided by the District Employment Exchange Peshawar, only 130 candidates attended the office for interview. The Committee interviewed 130 candidates one by one and asked about their willingness for the post and also their suitability for the post was also judged. After scrutiny of documents, the Committee recommended the following candidates for appointment against the post of Naib Qasid (BPS-01) and Residence Orderly (BPS-01).

Submitted that four posts of Naib Qasid (BPS-01) were lying vacant i.e two (02) consequent upon the retirement of Mr. Mukaram Khan Ex-Naib Qasid and death of Mr. Siyar Khan Ex-Naib Qasid while two posts are newly created vide Finance Department notification No. SOB(AD)6(24)/PSC/SNF/2014-15 dated 11.02.2015. Two posts of Naib Qasid (BPS-01) were filled up through initial appointment vide Secretary PSC office Order No. KP/PSC/Admn/GF-337/060488 dated 29.04.2015 and Office Order No. KP/PSC/Admn/GF-337/060504 dated 29.04.2015 while two posts of Naib Qasid are required to be filled up from the Class IV employee's son's quota, at the prescribed ratio of 25% out of total sanctioned posts. It is worth mention here that NOC from Deputy Commissioner for Class-IV employee's son's quota is not required as per instruction of the Government. Moreover, both of the candidates of Class-IV employees have submitted their applications and got registered with District Employment Exchange Peshawar. Therefore, their appointment against the reserved seats is in accordance with policy of the Government.



62 Mr. Shams-ul-Islam Naib Qasid PSC proceeded on retirement w.e.f. 30.06.2014 on attaining the age of superannuation. In pursuance of instructions contained in Establishment Department Notification No.SR-VII(E&AD) dated 22.03.2007 (Flag-B), it is mandatory to appoint one of the children of the retiring Government servant on superannuation against the vacant post at the prescribed ratio of 25% of sanctioned strength. The office of PSC is maintaining seniority list for the purpose of appointment of retiring Class-IV employees children vide page-66/C. Hence, it is evident that son of Mr. Shams-ul-Haq is on turn for appointment against 25% reserved seats of Class-IV employees.




SELECTION AGAINST ONE NEWLY CREATED POST OF ELECTRICIAN (BPS-02)
